TERMS AND CONDITIONS -

- 1. The Sale will be conducted by the undersigned through e-auction provided by the e-Auction service provider MSTC Ltd attheWebsite https://www.mstcecommerce.com on the date and time mentioned above. The intending Bidders/Purchasers are requested to on portal https://www.mstcecommerce.com (direct https://www.mstcecommerce.com/auctionhome/ibapi/index.jsp) using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take working days), the intending Bidders/Purchasers have to transfer the EMD amount using online mode in his Global EMD Wallet well in advance before the auction time. Bidder registration, submission &verification of KYC documents and transfer of EMD in wallet must be completed well in advance at least two days beforeauction date. The bid price to be submitted shall be equivalent or above the reserve price and during the e-auction bidders will be allowed to offer higher bid in inter-se bidding over and above the last bid quoted and by minimum increase in the bid amount given in the table to the last higher bid of the bidders.
