M/s Srl Ram Agro (Prop. Srl Ramesh Kumar) availed CC & TL facility from Indian Bank (e-Allahabad Bank), Khodaganj Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties", M/s Srl Ram Agro (Prop. Srl Ramesh Kumar) failed to pay the outstanding dues to the Bank.
