

TERMS AND CONDITIONS OF E-AUCTION SALE:

The sale shall be subject to the Terms & Conditions prescribed in the Security Interest(Enforcement) Rules 2002 and to the following further conditions:

- 1. The properties are being sold on "AS IS WHERE IS & AS IS WHAT IS BASIS".
- 2. The auction sale will be "Online through e-auction" portal.
- The interested bidders shall deposit the EMD through NEFT/RTGS the following Account- PUNJAB NATIONAL BANK, ARMB, E Auction Account No.4271002110004745 (IFSC - PUNB0427100).
- 4. The bidders shall improve their offer in multiple of Rs.10,000/-(Rupees Ten Thousand Only). In case bid is placed in the last 5 minutes of the closing time of the auction, the closing time will automatically get extended for 5 minutes.
- 5. The successful bidder shall have to deposit 25% of the bid/sale amount immediately to the account mentioned at Sl.No.3 above. The EMD shall be adjusted towards 25% of the bid/sale amount.
- 6. The successful bidder shall be required to deposit the balance 75% of the bid amount within 15 days from the date of confirmation of sale. In case of default in payment of the remaining 75% of the bid amount within the prescribed period, the entire amount deposited by the highest bidder including EMD will be forfeited by the Authorized officer without any notice and the property shall forthwith be put up for sale again and resold by the bank.
