11. Bank, the Secured Creditor, reserves the right to accept / reject the highest bid without assigning any reason thereof or to cancel the sale.

12. In case of bidding the same shall not be less than **Rs.10,000.00** in excess of highest bid amount or the immediate preceding bid, as the case may be with multiple increment value of **Rs. 10,000.00**

13. The sale will be confirmed in favor of the highest bidder and the confirmation of sale shall be subject to the confirmation by the Secured Creditor. **In case of single bid received, the sole bidder shall be declared as the successful bidder.**

13.1 Bids once made shall not be cancelled or withdrawn.

14. 15. 16. 19. Legal charges for conveyance, stamp duty and registration charges as applicable will be borne by the successful bidder.
